SUMMARY

GMP – Global Minority Protection is an ic3csi campaign.

GMP has two main jobs:

1. **Protect the White global minority** through clear, honest race classification and real safeguards – not fake victim stories.
2. **Define the IC3 Black race and IC6 Mixed-Black people clearly enough** to organise **reparatory justice** for IC3 Black and IC6 Mixed-Black hostages.

GMP uses the UK race and ethnicity systems (IC codes and 16+1 categories) as tools to tell the truth about:

- Who is the **global minority** (White people).
- Who is held as **hostages inside the global White-supremacist system** (IC3 Black and IC6 Mixed-Black people).
- What **repairs** are needed.

Strapline:

“Protect the White Global Minority. Repair IC3 Black and IC6 Mixed-Black hostages.”

1. PURPOSE OF GMP

GMP – Global Minority Protection exists to:

- **Name White people as a global racial minority**, not as the default “normal” human.
- **Show that real protection for any minority needs clear race definitions**, not blurred labels like “non-White” or “ethnic minority”.
- **Define and protect the IC3 Black race and IC6 Mixed-Black people** as a distinct hostage group inside a global White-dominated system.
- **Lay the foundations for reparatory justice** for IC3 Black and IC6 Mixed-Black people using proper classification, records and evidence.

GMP does **not** exist to attack White people as individuals.

GMP exists to **tell the truth about power, protect all groups fairly, and repair the harm done to IC3 and IC6.**


2. KEY DEFINITIONS

GLOBAL MINORITY

- The **small racial group in the whole world**, not just in one country.
- GMP uses **Global Minority** to describe **White people as a racial group**, recognised as a **numerical minority in global population terms**.

GLOBAL MAJORITY

- All the people in the world who are **not classified as White / IC1**.
- Includes IC2, IC3, IC4, IC5, IC6, IC7 and mixed categories.
- GMP does not use “Global Majority” to erase differences between groups, but to show that **most humans are not White**, even if institutions are still White-dominated.

IC CODES (RACE)

- **IC1** – White
- **IC2** – Mediterranean / European
- **IC3** – Black
- **IC4** – Asian (South Asian)
- **IC5** – Chinese / Japanese / East & Southeast Asian
- **IC6** – Arab / North African / “Dark European” / Mixed with those groups
- **IC7** – Unknown

GMP treats IC codes as **observed race codes** – how people are seen and treated.

IC3 BLACK RACE

- People classified as **IC3 Black** in the UK race policing system.
- This includes historic and present-day Black populations whose lives are shaped by **enslavement, colonisation and racialisation**.

IC6 MIXED-BLACK

- People who are **part Black and part something else** but who are still treated through the lens of Blackness in the system.
- GMP links IC6 Mixed-Black to IC3 Black for **reparatory justice**, while recognising their mixed position.

HOSTAGE STATUS

- GMP understands IC3 Black and IC6 Mixed-Black people as **hostages**, not free citizens, inside a **global White-supremacist financial, political and cultural world**.
- A **hostage** is someone whose choices and life chances are tightly controlled by a system built against them.
- Hostage status explains **why reparatory justice is needed** – the harm is not just past; it is **ongoing control**.

REPARATORY JUSTICE

- More than “compensation” or “an apology”.
- **Reparatory justice** means:
 - Admitting the truth about what has been done.

- Calculating the harm.
- Designing systems to **repair, restore and protect** IC3 Black and IC6 Mixed-Black hostages.
- GMP prepares the ground so this repair can be **targeted, organised and justified**.

3. PRINCIPLES OF GMP

1. TRUTH ABOUT NUMBERS

White people are a **global minority**.

GMP refuses language that treats White as the “normal human” and everyone else as the exception.

2. PROTECTION REQUIRES CLARITY

You cannot protect any group properly if you do not **define that group clearly**.

- Real protection for the White global minority needs **clear racial definition**, not vague categories.
- Real protection for IC3 and IC6 needs **precise IC coding, lineage, appearance, culture and DNA information**.

3. IC3 AND IC6 ARE PRIORITY HOSTAGES

Because of the trade in enslaved Black people, colonisation, and ongoing anti-Black racism, **IC3 Black and IC6 Mixed-Black people are priority hostages** inside the global system.

- GMP recognises **all groups' rights**,
but gives **special focus** to IC3 and IC6 for **reparatory justice**.

4. RACE AND ETHNICITY ARE LINKED, NOT BLURRED

GMP respects the UK reality:

- **Race codes (IC1-IC7)** – observed appearance.
- **Self-defined ethnicity (16+1 categories)** – how people describe their background.

GMP uses both systems **together** without pretending they are the same thing.
The link is **managed**, not **confused**.

5. NON-VIOLENCE AND RULE OF LAW

GMP is:

- **Non-violent.**
- Committed to **lawful methods**: evidence, classification, advocacy, negotiation, litigation where necessary.
- Focused on **systems change**, not revenge.

6. HOSTAGE REGISTRATION AND RECORDS

To repair IC3 and IC6, GMP supports:

- **Registration of IC3 Black and IC6 Mixed-Black hostages.**
- Careful recording of **birthplace, lineage, appearance, culture and DNA**.
- Use of existing systems (IDs, censuses, DNA services) until independent Black systems can be built.

4. WHY GLOBAL MINORITY PROTECTION IS NEEDED

A. THE OLD STORY

For hundreds of years:

- White powers have presented themselves as the **centre of civilisation**.
- Laws, borders, money and “race science” were designed mainly around **White advantage**.
- Black and Mixed-Black people were treated as **labour, resources, and problems**, not as full humans.

This created a **global White-supremacist system** that still shapes:

- Wealth
- Law
- Borders
- Policing
- Media
- Education

B. THE CONFUSED STORY

Modern language often talks about:

- “Ethnic minorities”
- “People of colour”
- “Global majority”
- “BAME / BME”

These labels are:

- Sometimes useful, but
- Often **too broad and too blurry** to support **real reparatory justice**.

If everybody non-White is lumped together, it becomes:

- Easier to hide the **specific harms to IC3 Black and IC6 Mixed-Black people**.
- Easier to dodge the question of **who exactly owes what to whom**.

C. THE GMP STORY

GMP offers a clearer structure:

1. **White = Global Minority**
 - Name it clearly.
 - Protect it honestly.
2. **IC3 Black and IC6 Mixed-Black = Hostage Group**
 - Name them clearly.
 - Record their harm precisely.
 - Prepare reparatory justice.
3. **Use IC codes and UK ethnicity systems as tools**
 - Not to blur everything,
 - But to **map the system and design the repair**.

5. WHAT GMP DOES

A. NAMING AND EDUCATION

- Explain **Global Minority** and **IC3 Black / IC6 Mixed-Black** in simple language.
- Teach that **clarity is protection** – if you cannot name a group, you cannot protect it.

- Show that telling the truth about the White global minority is **not an attack**, but a step towards fair systems.

B. HOSTAGE REGISTRATION SUPPORT

GMP supports work (by ic3csi and related bodies) to:

- Encourage IC3 Black and IC6 Mixed-Black people to **recognise their hostage status** inside the system.
- Register interest in reparatory justice.
- Connect identity information (birthplace, lineage, appearance, culture, DNA) to the IC3 / IC6 framework.

C. POLICY AND SAFEGUARDS ADVOCACY

GMP calls for:

- **Clear safeguards** in police, health, finance, education and courts for **IC3 Black and IC6 Mixed-Black people**.
- **Transparent recognition** of White people as a global minority in demographic and policy discussions.
- Use of IC codes and ethnicity categories to **monitor outcomes** and **expose racial harm**.

D. REPARATORY JUSTICE PREPARATION

GMP helps to:

- Gather the **classification, data and narratives** needed for future reparatory justice processes.
- Clarify that **reparations are not charity**, but **structured repair** owed to IC3 and IC6 hostages.
- Support the development of systems (such as registries and, later, RLT and other tools) that can organise reparatory obligations.

6. RELATIONSHIP TO IC3CSI

ic3csi (ic3 Crime Scene Investigators) is the investigative and documentation arm.

- It collects and organises **evidence of racial harm**, including financial, legal and institutional cases.

- It promotes tools such as **Reparation Liability Tokens (RLT)** and maintains a **registry of interest** in reparatory justice.

GMP is one of ic3csi's **campaign frameworks**.

- Where ic3csi looks at the individual and institutional “crime scenes”,
- **GMP provides the big public story:**
 - White = Global Minority
 - IC3 & IC6 = Hostages needing repair
 - Clear codes = Clear justice

Together:

- **ic3csi** = investigation, evidence, technical systems.
- **GMP** = public language, education, and political framing.

GMP is an ic3csi campaign that tells the truth about race and justice.

GMP uses UK race and ethnicity codes to show who has been harmed and to prepare **reparatory justice for IC3 Black and IC6 Mixed-Black hostages**. When every group is named clearly, every group can be protected – and the people who suffered the most can finally be repaired.

“Protect the White Global Minority. Repair IC3 Black and IC6 Mixed-Black hostages.”
