FOUNDATIONAL CHARTER AND ORIGIN NARRATIVE OF THE IC3 BLACK INTERNATIONAL STATE (IBIS)

PURPOSE

This document explains how the ic3 Black International State (IBIS) came into being and clarifies the roles, relationships, and guardrails between the following elements, using complete terms with abbreviations for clarity to new readers: The Reparation Nation Limited; ic3 Crime Scene Investigators (ic3csi); ic3 Black International State (IBIS); Justice Trade Certification (JTC); Reparation Liability Tokens (RLT).

I. ORIGINS — THE REPARATION NATION LIMITED

Foundational mission. The Reparation Nation Limited initiated a structured, public-facing campaign to develop reparatory justice delivery systems. The Reparation Nation Limited is not the final Black organisation; it prepared the ground for a future sovereign authority and stewarded the early-stage civic work required to reach that outcome.

Early functions. The Reparation Nation Limited convened stakeholders, gathered evidence, ran outreach and education, encouraged the use of standardised race and ethnicity language, and piloted community-facing programmes to surface institutional requirements.

Strategic discovery. Through this work, The Reparation Nation Limited identified the need for a specialised unit to design and safeguard the intellectual architecture of reparatory justice in clear public language and to keep the record of ideas clean and trustworthy. That unit became ic3 Crime Scene Investigators (ic3csi).

II. THE INTELLECTUAL ARCHITECTURE — IC3 CRIME SCENE INVESTIGATORS (IC3CSI)

Establishment and remit. ic3 Crime Scene Investigators (ic3csi) is the originating body for the ideas, frameworks, narrative, and public education underpinning three core instruments: Justice Trade Certification (JTC), ic3 Black International State (IBIS), and Reparation Liability Tokens (RLT). ic3 Crime Scene Investigators (ic3csi) holds the intellectual property for Justice Trade Certification (JTC), ic3 Black International State (IBIS), and Reparation Liability Tokens (RLT).

Scope today. ic3 Crime Scene Investigators (ic3csi) promotes understanding of Justice Trade Certification (JTC), ic3 Black International State (IBIS), and Reparation Liability Tokens (RLT); drafts discussion papers; curates foundational principles; and maintains

public clarity. ic3 Crime Scene Investigators (ic3csi) may keep a registry of interest for supporters, but it does not operate rails, identity systems, or token contracts.

Boundaries. ic3 Crime Scene Investigators (ic3csi) does not issue Justice Trade Certification (JTC), and does not mint, burn, update, or settle Reparation Liability Tokens (RLT). It is not a payments rail or a currency issuer. This separation preserves integrity and avoids conflicts when sovereign powers move to the ic3 Black International State (IBIS).

III. THE SOVEREIGN AUTHORITY — IC3 BLACK INTERNATIONAL STATE (IBIS)

Reason for formation. To ensure legitimacy, accountability, and clarity in execution, the powers to certify and to manage liability records must be exercised by a sovereign authority with a clear mandate. The ic3 Black International State (IBIS) was formed to perform that role.

Mandate (exclusive). The ic3 Black International State (IBIS) is the sole authority that will:

- Issue Justice Trade Certification (JTC).
- Mint, burn, update, and settle Reparation Liability Tokens (RLT).
- Set policy, governance, audit standards, and enforcement frameworks for programmes it operates.
- Create, in due course, its own Black Currency.

Relationship to ic3 Crime Scene Investigators (ic3csi). ic3 Crime Scene Investigators (ic3csi) provides the intellectual architecture and public education; the ic3 Black International State (IBIS) provides sovereign execution and governance. Justice Trade Certification (JTC) and Reparation Liability Tokens (RLT) are the intellectual property of ic3 Crime Scene Investigators (ic3csi) but are governed and operated by the ic3 Black International State (IBIS).

IV. THE CERTIFICATION STANDARD — JUSTICE TRADE CERTIFICATION (JTC)

Definition and purpose. Justice Trade Certification (JTC) is a formal certification issued only by the ic3 Black International State (IBIS) to recognise organisations and programmes that meet justice-aligned principles and requirements set by the ic3 Black International State (IBIS). Justice Trade Certification (JTC) exists to create a trustworthy public signal that commerce and programmes are aligned with defined standards (for example, truthful marketing, fair dealing, anti-Black racism safeguards, transparent reporting, community benefit, and responsible data practices).

Issuance authority. Only the ic3 Black International State (IBIS) can issue Justice Trade Certification (JTC). Any advisory or readiness activities by ic3 Crime Scene Investigators (ic3csi) are explicitly not certification.

Separation from ledgers and money. Justice Trade Certification (JTC) is not money, is not a payments rail, and does not itself carry value or confer financial rights. Justice Trade Certification (JTC) has no programmatic write access to Reparation Liability Tokens (RLT).

Public trust. By clearly separating Justice Trade Certification (JTC) from ledgers and currencies, the ic3 Black International State (IBIS) ensures that certification retains credibility, is auditable against published standards, and cannot be confused with financial instruments.

V. THE LIABILITY LEDGER — REPARATION LIABILITY TOKENS (RLT)

Definition and purpose. Reparation Liability Tokens (RLT) are not money and are not transferable. Reparation Liability Tokens (RLT) are entries on a sovereign ledger that record, for each entity, the status of reparatory liability as recognised by the ic3 Black International State (IBIS). Reparation Liability Tokens (RLT) exist to measure and display, in an accountable and auditable way, the standing of obligations and the effect of legitimate remedies recognised by the ic3 Black International State (IBIS).

Sovereign control. Only the ic3 Black International State (IBIS) can mint, burn, update, or settle Reparation Liability Tokens (RLT). No other entity has authority over the Reparation Liability Tokens (RLT) ledger.

Key properties.

- **Non-transferable:** Reparation Liability Tokens (RLT) cannot be traded, sold, or moved between parties.
- **Not a currency:** Reparation Liability Tokens (RLT) do not represent cash, equity, or debt and do not function as a medium of exchange.
- **Evidence-based updates:** Reparation Liability Tokens (RLT) change only when the ic3 Black International State (IBIS) accepts recognised remedies or outcomes through its published processes.

Guardrail with Justice Trade Certification (JTC). Justice Trade Certification (JTC) must not impact Reparation Liability Tokens (RLT) in any way. Justice Trade Certification (JTC) has no write access to Reparation Liability Tokens (RLT). The ic3 Black International State (IBIS) may, at its sole discretion, reference information from certified activity, but any decision to update Reparation Liability Tokens (RLT) rests only with the ic3 Black International State (IBIS).

VI. SOVEREIGNTY AND INTEGRITY CLAUSES

Exclusive authorities.

- Only the ic3 Black International State (IBIS) issues Justice Trade Certification (JTC).
- Only the ic3 Black International State (IBIS) mints, burns, updates, and settles Reparation Liability Tokens (RLT).

No cross-control.

- Justice Trade Certification (JTC) has no write access to Reparation Liability Tokens (RLT).
- No external programme, currency, or third party may claim authority over Justice Trade Certification (JTC) or Reparation Liability Tokens (RLT).

Currency principle. The ic3 Black International State (IBIS) will create its own Black Currency in due course, separate from any other monetary or token initiatives.

Intellectual property and usage. Justice Trade Certification (JTC), ic3 Black International State (IBIS), and Reparation Liability Tokens (RLT) are the intellectual property of ic3 Crime Scene Investigators (ic3csi). Any third-party reference to these terms must respect the definitions, guardrails, and governance stated herein.

VII. GOVERNANCE AND ACCOUNTABILITY (HIGH-LEVEL)

Policy setting and updates. The ic3 Black International State (IBIS) will publish policies and updates for Justice Trade Certification (JTC) and Reparation Liability Tokens (RLT), including standards, audit methods, due process for recognition of remedies, and procedures for appeals or reviews.

Transparency. The ic3 Black International State (IBIS) will provide periodic public reporting on certification activity related to Justice Trade Certification (JTC) and on aggregate statistics for Reparation Liability Tokens (RLT), while maintaining appropriate confidentiality and data protection.

Public participation. ic3 Crime Scene Investigators (ic3csi) may host consultations, listening sessions, and educational briefings to help the public understand Justice Trade Certification (JTC), the ic3 Black International State (IBIS), and Reparation Liability Tokens (RLT). Participation does not confer certification or change any Reparation Liability Tokens (RLT) status.

VIII. DEVELOPMENT TIMELINE (CONCEPTUAL)

Phase A — The Reparation Nation Limited. Public mobilisation, education, and discovery; identification of institutional needs; articulation of problems and objectives.

Phase B — ic3 Crime Scene Investigators (ic3csi). Creation and protection of the intellectual architecture; publication of principles and definitions for Justice Trade Certification (JTC), ic3 Black International State (IBIS), and Reparation Liability Tokens (RLT); registry of interest and education.

Phase C — ic3 Black International State (IBIS). Formation of the sovereign authority for execution; assumption of certification and ledger powers; publication of governance, audit, and enforcement frameworks; roadmap toward the creation of a dedicated Black Currency.

Phase D — Justice Trade Certification (JTC). Operational issuance of certification by the ic3 Black International State (IBIS) according to published standards; audits and renewals; sanctions for misuse.

Phase E — Reparation Liability Tokens (RLT). Operation of the sovereign ledger by the ic3 Black International State (IBIS); publication of processes for recognition of remedies; non-transferable entries reflecting obligation status under the authority of the ic3 Black International State (IBIS).

IX. CANONICAL DEFINITIONS

- **“ic3 Crime Scene Investigators (ic3csi)”** — The originating body for the ideas, frameworks, and educational materials; holder of the intellectual property for “Justice Trade Certification (JTC)”, “ic3 Black International State (IBIS)”, and “Reparation Liability Tokens (RLT)”.
- **“ic3 Black International State (IBIS)”** — The sovereign authority that manages “Justice Trade Certification (JTC)” and “Reparation Liability Tokens (RLT)” and will create its own Black Currency.
- **“Justice Trade Certification (JTC)”** — A certification standard issued only by the “ic3 Black International State (IBIS)” to recognise justice-aligned practice; not money; no write access to “Reparation Liability Tokens (RLT)”.
- **“Reparation Liability Tokens (RLT)”** — Non-transferable ledger entries governed only by the “ic3 Black International State (IBIS)” that record reparatory liability status; not money.

X. COMMON MISUNDERSTANDINGS AND CORRECTIONS

“Does Justice Trade Certification (JTC) change Reparation Liability Tokens (RLT)?”
No. Justice Trade Certification (JTC) has no write access to Reparation Liability Tokens (RLT). Only the ic3 Black International State (IBIS) can update Reparation Liability Tokens (RLT).

“Can ic3 Crime Scene Investigators (ic3csi) issue Justice Trade Certification (JTC) or operate Reparation Liability Tokens (RLT)?”

No. ic3 Crime Scene Investigators (ic3csi) stewards the intellectual property and public education. Only the ic3 Black International State (IBIS) issues Justice Trade Certification (JTC) and governs Reparation Liability Tokens (RLT).

XI. CLOSING STATEMENT

The Reparation Nation Limited laid the groundwork. ic3 Crime Scene Investigators (ic3csi) created and protected the intellectual architecture. The ic3 Black International State (IBIS) now stands as the sovereign authority to issue Justice Trade Certification (JTC) and to govern Reparation Liability Tokens (RLT), with a clear currency principle: the ic3 Black International State (IBIS) will create its own Black Currency. This structure preserves integrity, prevents confusion, and provides the foundation for accountable, standards-based progress in reparatory justice.
