Black authority mandate (ic3csi):

IC3CSI (IC3 Crime Scene Investigators) is a Black-led investigatory and documentation body focused on the safety, dignity and reparatory justice of IC3 Black and IC6 Mixed-Black people. We assert a Black authority mandate to scrutinise, question and challenge any past, present or planned activities and decisions that affect IC3 Black and IC6 Mixed-Black people, and to raise concerns and proposals through lawful written channels.

Communication policy (ic3csi):

ic3csi representatives will not voluntarily meet police officers, or any other entities suspected of anti-Black racism, face-to-face. All communications must be in writing (email or post) for transparency and evidential record-keeping. This policy reflects our role representing IC3 Black and IC6 Mixed-Black people and ongoing concerns about anti-Black racism and institutional racism. If officers or other parties approach us in person unprompted, that is a different matter.

Overview of Correspondence

This file documents a high-level strategic exchange between **IC3CSI (The Reparation Nation Limited)** and **Cecil Gutzmore**, a prominent Black academic. The thread centers on your recent distribution of a review regarding David Lammy and Black Power, authored or researched by George T. Nomen.

1. The Initial Communication (The Trigger)

Sender: IC3CSI / The Reparation Nation Limited **Date:** 25 January 2026

Context: You distributed a mass email titled "DAVID LAMMY REVIEW AND BLACK POWER" to a wide network of community figures and activists.

2. The Strategic Challenge (The Response from Cecil Gutzmore)

Key Challenges Raised by Gutzmore:

Dear Cecil,

Thank you for engaging critically. I welcome the challenge and respond directly.

1. Why revisit Lammy now

We are presenting David Lammy's *own* earlier positions to test continuity and accountability in his *current* office and responsibilities. This is not historical curiosity; it is a record-based inquiry into what he still stands by and what he has acted upon.

2. Updating—not recycling—the analysis

We are correcting a structural weakness in earlier discourse by removing the collapsing value of "BAME" and applying UK race and ethnic codification that is precise, disaggregated, and actionable. This enables policy design, measurement, and remedy by group—rather than narrative acknowledgment without implementation.

3. From critique to implementation

Our work offers an implementation pathway: codification standards, evidential thresholds, and repeatable methods for documentation and correspondence. This is designed to move beyond debate into measurable change.

4. Purpose of engagement with Lammy

We hope Lammy will recognise this work as an opportunity to state his *current* position plainly—what he still endorses, what he

rejects, and what he will replace it with—and to use his office to effect real change.

5. On Sewell

Sewell is not a relevant comparator here. It neither supersedes the need to test Lammy's accountability nor provides a usable framework for protecting IC3 Black and IC6 Mixed-Black people. Our focus is outcomes and safeguards, not report hierarchies.

6. Authorship and collaboration

I did not author the review myself for two reasons:

- I am not an academic and do not claim mastery of the English language at the level required for this task. George brings that expertise.
- George is the only IC3 Black academic I could secure to join the IC3CSI think tank. Other Black intelligentsia have, to date, declined to engage or have not considered this work of sufficient value. That reality is precisely why independent infrastructure is necessary.

7. Accountability-by-record

IC3CSI operates through written correspondence to create an evidential trail. This protects against policy drift and ensures positions and actions can be audited.

8. Method over personality

This is non-partisan and non-personal. The test is whether institutions adopt methods that actually protect people—classification, documentation, and remedy—not who commissioned which report.

9. COVID as confirmation, not distraction

COVID exposed the consequences of poor classification and aggregated categories. Our framework addresses that failure directly by requiring precision before policy.

10. Invitation to strengthen the work

I welcome rigorous critique of the *method*. If you—or others—wish to propose improvements, co-sign revisions, or stress-test the framework, that would strengthen it.

Respectfully, this is about building missing infrastructure: a reliable identity schema, evidential discipline, and a lawful route from community knowledge to state action. Without that, reports remain commentary.
