Please find attached documents concerning the Metropolitan Police/Axon Evidence Submission Portal provided to me on **29 August 2026**.

The evidence submission request stated that **L. Farr had requested evidence from me** and expressly stated:

“Link is valid for 30 days.”

However, when I attempted to use the portal on **1 September 2026**, it displayed:

“We are no longer accepting submissions for this portal.”

The stated 30-day period had not expired.

I therefore respectfully request that this email and the attached documents are **forwarded immediately to L. Farr and/or the Officer in the Case**.

I request:

- 1. Immediate restoration of Community Request 01/GD/11602/26, or provision of a replacement evidence-submission link;**

2. a written explanation of why the portal ceased accepting submissions before expiry of the stated 30-day period;
3. preservation of all records, logs and audit information relating to the operation, alteration, closure or expiry of Community Request 01/GD/11602/26; and
4. written confirmation that this email and its attachments have been received and forwarded to the appropriate officer.

The material I intended to submit includes questions concerning safeguards against **anti-Black racism and institutional racism**. I intended to use the Police-provided facility so that there would be a clear record of submission and an opportunity for the Police to respond before my next Crown Court hearing.

For the avoidance of doubt, **I make no allegations, no accusations, no assertions and no assumptions concerning why the portal ceased accepting submissions, and I have reached no conclusion concerning the reason.** I am asking for the facts, an explanation, and restoration or replacement of the evidence-submission facility.

Because my next hearing at Wood Green Crown Court is on **16 September 2026**, I request that this matter is dealt with without delay.
